- The SARs vest in four equal annual installments beginning on February 3, 2015. The vested and unexercised portion of the SARs, if any, shall be automatically exercised if the closing price of the issuer's common stock equals or exceeds a specified "maximum share value" equal to \$75.
- Restricted Stock Units settle in Class A Common Stock on a 1:1 basis.
- Restricted Stock Units vest and convert to Class A Common Stock in two equal installments on February 3, 2016 and February 3, 2018.
